## First Sentier Investors ICVC Non-Dealing Days

This document shows the schedule of upcoming Non-Dealing Days applicable to sub-funds of First Sentier Investors ICVC.

Table 1 sets out the Non-Dealing Days arising from bank holidays in England when all sub-funds are closed for dealing.

Table 2 sets out additional Non-Dealing Days arising for certain sub-funds. Additional Non-Dealing Days have been declared here because a material portion of the portfolio of these funds is invested in one or more markets which will be closed.

Dealing instructions received for or during a Non-Dealing Day will be deferred until the next Dealing Day.

Non-Dealing Days are not classed as Business Days. Accordingly, the settlement period of subscriptions, redemptions, and switches may be extended when a Non-Dealing Day falls between the trade date and the settlement date.
